I, Dr. S. K. Jain, Practicing Company Secretary of Mumbai has been appointed as the Scrutinizer by the Board of Directors of **TIME TECHNOPLAST LIMITED** at its Meeting held on 14th February, 2019 as the Scrutinizer for conducting Postal Ballot / e-Voting process and I have given my consent to act as Scrutinizer vide letter dated 14th February, 2019 for passing of the following Special Resolutions by Postal Ballot:

### SPECIAL RESOLUTIONS

- 1. To Issue the Non-Convertible Debentures through Private Placement.
- 2. To Continue Directorship of Shri, Kuthoore Natarajan Venkatasubramanian (DIN: 00007392) Chairman and Non-Executive Independent Director of The Company on Attaining Age of Eighty Years (80).

I hereby submit my Report as under:-

- a. The Company completed the dispatch of the Postal Ballot Notice along with the Postal Ballot Forms and pre-paid self-addressed Envelopes to all the Shareholders through courier and also sent the said documents through email to the Shareholders whose e-mail ids are registered with the Company. The said process was completed by 08th March, 2019.
- b. The Company had made an advertisement regarding dispatch of Postal Ballot Forms/Notices in Free Press Journal (English Newspaper), Navshakti (Marathi Newspaper) and in Gujarat Mitra (Gujarati Newspaper) on Saturday, 09th March, 2019.
- c. The Company has availed the services of CDSL [Central Depository Services (India) Limited] to provide e-Voting facilities to the Members of the Company.

- d. The remote e-Voting commenced from 9:00 a.m. (IST) on 09th March, 2019 and ended at 5:00 p.m. (IST) on 07th April, 2019.
- e. I have monitored the process of electronic voting through the Scrutinizer's secured link provided by CDSL on the designated website www.evotingindia.com
- f. The Postal Ballot Forms received during the voting period were kept under my safe custody and were opened in my presence. The e-Voting module was unblocked at 5:15p,m. on 07<sup>th</sup> April, 2019 in the presence of two witnesses, Ms. Nivyata Batavia and Mr. Karan Pradip Varma, who are not in the employment of Time Technoplast Limited. They have signed below in confirmation of the votes being unblocked in their presence and the e-Voting results/list was downloaded from the CDSL website.

- g. All Postal Ballot Forms received and e-Votes casted up to 5:00 p.m. on 07th April, 2019, the last date and time fixed by the Company for receipt of the votes/forms were considered for my Scrutiny.
- h. There were 30,893 Members of the Company on cut-off date i.e. 22<sup>nd</sup> February, 2019. Out of 30,893 Members, 26,907 Members had registered their e-mail id with Link Intime India Private Limited (R&T) and accordingly Postal Ballot Forms were sent to the Members through e-mail on 08<sup>th</sup> March, 2019. To the remaining 3986 Members, the Postal Ballot Notices along with Postal Ballot Forms were sent through Courier on 08<sup>th</sup> March, 2019. Out of 26,907 e-mails, 1857 e-mails bounced back and the Postal Ballot Notices were physically dispatched to the said Shareholders on 12<sup>th</sup> March, 2019.
- I. I received total 54 Postal Ballot Forms from the Members of the Company. The Postal Ballot Forms were scanned and sent to Link Intime India Private Limited (R&T) for verification of signatures and other details. Link Intime India Private Limited have intimated that 54 Postal Ballot Forms were received, Out of which 6 Forms were found invalid due to the Signature Mismatch and 4 Forms were found invalid as Members had casted their votes through e-voting Hence these Forms were not considered.





- j. I did not find any defaced or mutilated Ballot paper.
- k. The particulars of all the Postal Ballot Forms received from the Members in Physical Form and Electronic Voting Report generated from CDSL have been entered in a Register separately maintained for the purpose.
- 1. Detailed summary of Result with assent/dissent for the Resolutions is attached with this report as Annexure I.
- m. The Resolutions were passed by the requisite majority.
- n. I have handed over the Postal Ballot Forms and other related papers/registers and records for safe custody to the Company Secretary of the Company.
- You may accordingly declare the result of the voting by Postal Ballot and e-Voting.
