Sub: Order Received for Supply of High-Density Polyethylene (HDPE) Pipe Products

Ref: Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements)
Regulations, 2015

We are pleased to announce the receipt of a order from EPC (Engineering, Procurement, and Construction) Contractor for approximately ₹190 Cr for the supply of HDPE Pipe Products in Power Duct application projects carried in: 1. Amaravathi Development Corporation Limited, and 2. Andhra Pradesh Capital Region Development Authority.

Considering this order, the Company's cumulative order book for HDPE Pipe segment stands at around ₹280 Cr. The company's installed manufacturing capacity enables it to produce HDPE Pipe Products of ₹450 Cr (approximately) annually. HDPE Pipe products are voluminous in nature; therefore the company has four (4) manufacturing facilities across India: {one (1) in the Western Region (Silvassa, U.T.), two (2) in the Southern Region [Gummidipoondi (near Chennai), Tamil Nadu and Medchal (near Hyderabad City), Telangana], and one (1) in the Eastern Region [Amta (near Kolkata), West Bengal]}.

In FY 2024–25, company's revenue from the HDPE Pipe Products segment stood at around ₹283 Cr, reflecting robust demand and execution capabilities. With substantial investments undertaken by the Government authorities in India's infrastructure and smart city development projects, the Company anticipates the Indian pipe market to grow at a Compounded Annual Growth Rate (CAGR) exceeding 20%, offering major opportunities for sustained growth and market expansion.
